

This is with reference to the application of the A.P. State Open School, Hyderabad for membership of COBSE.



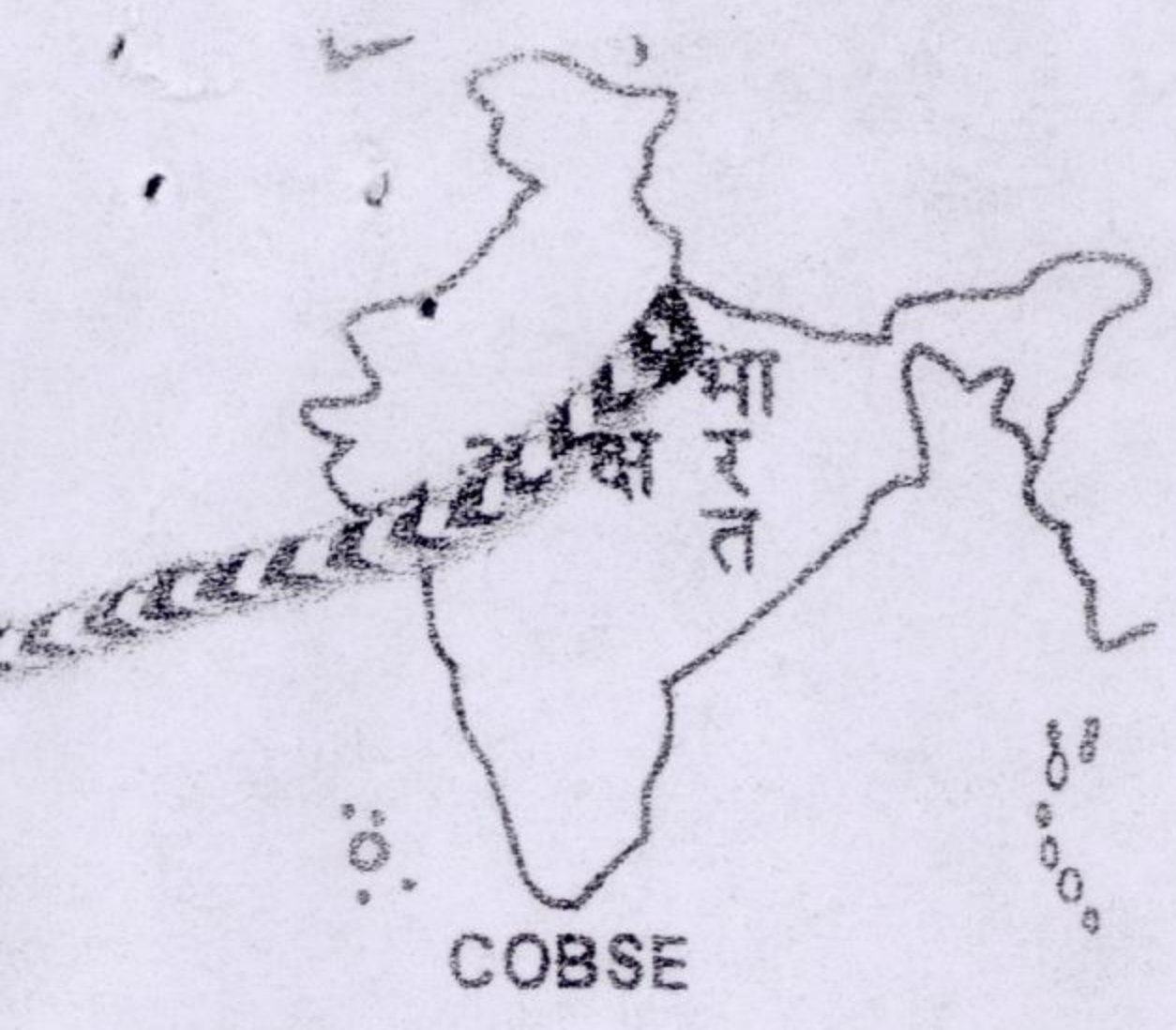
